**COUNTS 1 AND 2: THEFT, a Class 5  
Felony, in violation of A.R.S. § 13-1802**

**COUNT 3: DUTIES AND  
LIABILITIES OF CUSTODIAN OF  
PUBLIC MONIES; VIOLATIONS; a  
Class 4 Felony, in violation of A.R.S. § 35-

The Arizona State Grand Jury accuses **ROSA MARIA ORDONEZ. (001)**,  
charging on this \_\_\_\_\_, 2021 that in or from Pima County, Arizona:

**COUNT 1**  
**THEFT, A CLASS 5 FELONY**

From on or about July 17, 2018, through August 28, 2018, **ROSA ORDONEZ**,  
committed theft with a value of one thousand dollars or more but less than two thousand  
dollars, to wit: change fund money issued by the district to provide change to customers  
at athletic events and in the bookstore, in violation of A.R.S. §§ 13-1802(A), 13-108, 13-

109, 13-301, 13-302, 13-304, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, 13-2314.

**COUNT 2**  
**THEFT, A CLASS 5 FELONY**

From on or about July 26, 2018 and continuing through on or about August 20, 2018, **ROSA ORDONEZ**, committed theft with a value of one thousand dollars or more but less than two thousand dollars, to wit: 66 deposits received by Ordonez but not located in the bookstore or it's accounts, in violation of A.R.S. §§ 13-1802, 13-108, 13-109, 13-301, 13-302, 13-304, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, 13-2314.

**COUNT 3**  
**VIOLATION OF DUTIES AND LIABILITIES OF CUSTODIAN OF PUBLIC,**  
**MONIES, CLASS 4 FELONY**

On or about July 2018 and continuing through on or about August 2018, **ROSA ORDONEZ**, was charged with receiving, safekeeping, transferring or disbursing public monies and without authority of law, appropriated moneys, or any portion thereof, to her own use and/or knowingly failed to keep monies in her possession until disbursed or paid by authority of law in violation of A.R.S. § 35-301(1) and (3), 35-302, 13-108, 13-109, 13-301, 13-302, 13-304, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, 13-2314.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Pima County, Arizona.
