**COUNT 1**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: video titled "3FLEBB81-AD85-40DF-BF37-9F1204C1B436.MOV"), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 2**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: video titled "IMG\_2502.MP4"), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 3**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: video titled "IMG\_3456.MP4"), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 4**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or

exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: video titled "IMG\_3891.MP4"), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 5**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: video titled "IMG\_4295.MP4"), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 6**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: image titled "photo\_78@08-04-2019\_16-03-13.jpg"), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 7**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: image titled "photo\_130@23-11-2019\_15-27-20.jpg"), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 8**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: image titled “photo\_133@23-11-2019\_15-27-46.jpg”), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 9**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: image titled “photo\_276@30-11-2019\_10-45-40.jpg”), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

**COUNT 10**

**SEXUAL EXPLOITATION OF A MINOR**

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: video titled “video\_2@08-04-2019\_16-04-20.MP4”), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

COUNT 11

SEXUAL EXPLOITATION OF A MINOR

On or between April 13, 2020 and December 08, 2020, **RYAN WILLIAM HOBURG**, knowingly distributed, received, electronically transmitted, possessed or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitative exhibition or other sexual conduct (to wit: video titled "video\_13@30-11-2019\_13-42-49.MP4"), in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-701, 13-702, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
