The Attorney General of the State of Arizona hereby accuses JOSEPH JAMES MIERZEJEWSKI (001), charging that in Pima County:

COUNT ONE:

FRAUDULENT SCHEMES AND ARTIFICES, A CLASS 2 FELONY

On or about April 25th, 2021, and continuing on through December 31, 2021, JOSEPH JAMES MIERZEJEWSKI (001), pursuant to a scheme or artifice defrauded Target and/or Home Depot and/or Walmart, to receive a benefit by means to false or fraudulent pretenses, representations or material omissions. In violation of A.R.S. §§ 13-2310(A), 13-301, 13-302, 13-303, 13-304, 13-603, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, and 13-2314.

The fraudulent schemes artifices involved and JOESEPH **JAMES** MIERZEJEWSKI (001) entering various retail establishments and fraudulently applying and scanning at self-check-out stations, a Universal Product Code of lesser value to avoid paying the item's true purchase price. JOSEPH JAMES MIERZJEWSKI (001) later trafficked the stolen property by pawning the items in exchange for currency.

COUNT TWO

TRAFFICKING IN STOLEN PROPERTY, A CLASS 2 FELONY

On or about June 17, 2021 and continuing through December 13, 2021, JOSEPH JAMES MIERZEJEWSKI (001), knowingly initiated, organized, planned, or directed the theft of wit: Lego Sets, Power Tools, Power Tool Related Equipment, and Miscellaneous Household Items, and trafficked the property of another that has been stolen, to wit: selling stolen merchandise to various pawn stores in Pima County, in

violation of A.R.S. §§ 13-2307(B), 13-301, 13-302, 13-303, 13-304, 13-603, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, and 13-2314.

COUNT THREE

TRAFFICKING IN STOLEN PROPERTY, A CLASS 2 FELONY

On or about March 18, 2022, **JOSEPH JAMES MIERZEJEWSKI** (001), knowingly initiated, organized, planned, or directed the theft of wit:, Power Tools, Power Tool Related Equipment, and Miscellaneous Household Items, with the intent to traffic the property of another that has been stolen, to wit: possessing stolen merchandise with the intent to resell the items, in violation of A.R.S. §§ 13-2307(B), 13-301, 13-302, 13-303, 13-304, 13-603, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, and 13-2314.

COUNT FOUR

ORGANIZED RETAIL THEFT, A CLASS 4 FELONY

On or about April 25, 2021 and continuing through July 3, 2021, **JOSEPH JAMES MIERZEJEWSKI (001)**, removed merchandise, to wit: Lego Sets, a Knife Set and a Suvie Cooker, from Target, without paying the purchase price, with the intent to resell or trade the merchandise in violation of A.R.S. §§ 13-1819(A), 13-301, 13-302, 13-

303, 13-304, 13-603, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, and 13-2314.

COUNT FIVE

ORGANIZED RETAIL THEFT, A CLASS 4 FELONY

On or about June 6, 2021, and continuing through July 2, 2021, **JOSEPH JAMES MIERZEJEWSKI (001)**, removed merchandise, to wit: Power Tools and Power Tool

Equipment, from Home Depot Stores, without paying the purchase price, with the intent to resell or trade the merchandise in violation of A.R.S. §§ 13-1819(A), 13-301, 13-302, 13-303, 13-304, 13-603, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, and 13-2314.

COUNT SIX

ORGANIZED RETAIL THEFT, A CLASS 4 FELONY

On or about July 1, 2021 and continuing through December 31,2021, **JOSEPH JAMES MIERZEJEWSKI (001)**, removed merchandise, to wit: Miscellaneous Household Items, from Walmart stores, without paying the purchase price, with the intent to resell or trade the merchandise in violation of A.R.S. §§ 13-1819(A), 13-301, 13-302,
