CHARGING VIOLATIONS OF:

**COUNTS 1-10: SEXUAL  
EXPLOITATION OF A MINOR**, Class 2  
Felonies and Dangerous Crimes Against

The Arizona State Grand Jury accuses **SHANE PERRY ANDERSON**, charging

possessed, or exchanged a visual depiction in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, TO WIT: 1.wmv, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.


Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
